Directions From North Charlottesville: Exit I-64, at Rt. 20 south. Go through Scottsville, VA. Cross Slate River Bridge, turn right on Rt.

649, or Slate River Mill Road. Pass Rt. 658, Saint Andrews Church Rd., Go through wooded area. When get to wooden fence on left, entrance gate on left. There will be dog signs at gate.

From I-64 at Zion CrossRoads and Rt. 15: Go south on Rt. 15 through Fork Union and cross James River Bridge. Go through Dillwyn to Rt. 60 at Sprouses' Corner.
