I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. All stakes will be run on a single course without birdfield. Released and native quail in all stakes except Open Puppy. AKC approved tracking devices may be used. A .22 cal blank pistol with solid barrel will be used in all stakes. Horseback handling is permitted in all stakes.

Use of cell phones on courses during the trial is strictly prohibited.

A Sport Dog Training Collar will be awarded to the winner of the Amateur Gundog.

Rosettes will be awarded to all placing dogs.

All placing dogs in all stakes will be credited with points towards the Association of Virginia Field Trial Clubs (AVFTC) Dogs of the Year Awards.
