## **Directions**

**From North Charlottesville:** Exit I-64, at Rt. 20 south. Go through Scottsville, VA. Cross Slate River Bridge, turn right on Rt. 649, or Slate River Mill Road. Pass Rt. 658, Saint Andrews Church Rd., Go through wooded area. When get to wooden fence on left, entrance gate on left. There will be dog signs at gate.

**From I-64 at Zion CrossRoads and Rt. 15:** Go south on Rt. 15 through Fork Union and cross James River Bridge. Go through Dillwyn to Rt. 60 at Sprouses' Corner. Follow Rt. 60 west through

Buckingham Courthouse and 35 MPH. Just after CH, turn right on Rt. 648 or Hall Road. Road narrows and stop at fork. Go right on Rt. 649 or Slate River Mill Road. Go half of a mile to gate on right. There will be dog signs at entrance.

**From Rt. 460 at Farmville:** Go north on Rt. 15 to Sprouses' Corner. Go west on Rt. 60. Follow directions above.

**From Rt. 460 and Lynchburg & I-81:** At Appomattox, take Rt 24 east to Rt. 60 east. Go 60 east and pass Blue Va Wayside sign. At bottom of hill turn left onto Rt. 648 and go to Rt. 649. Take right on Rt 649 and the gate entrance is half of a mile on right.
